For persons living outside of the Parish of Boughton under Blean, who wish to be buried in Boughton under Blean Civic Cemetery, a strong connection with the village must be demonstrated to the satisfaction of the Parish Council.

In the event that such a burial is approved, all fees and payments will be doubled, subject always to the right of the Parish Council to waive the requirement to pay double fees at its discretion.

The double payment will not apply to persons who have left accommodation in the village to go directly to a care home or hospital because of ill health or residential care requirements
